Public Hearing #2 on the 2024 Proposed Budget was held at 9:00 am in the Conference Room of the Claiborne Parish Police Jury Administrative Building.

President Scott Davidson read aloud a notice – The annual CPI & Landfill letter for Republic services received December 9, 2023, will be increased by \$0.41 per household for pick up in the parish. The increase will be from \$16.26 to \$16.67 per household at a total cost of approximately \$785,500 per year for curbside trash pickup in the Parish (not including the incorporated areas of Homer and Haynesville).

At this time, President Scott Davidson presented the Road Committee Report.

Upon motion by Kevin Gray, duly seconded by Mark Furlow, the Jury unanimously approved, upon recommendation from the Road Committee, the posting for an open Truck Driver Position for the CPPJ Hwy Dept. This is due to the fact that Mike Ellis has informed the Jury that he will be retiring.

At this time Claiborne Parish Coroner Dr. Mark Haynes gave the January update for the Coroner's Office. There were twelve (12) total deaths: six (6) Hospice/ER related, one (1) required autopsy, four (4) were on scene no autopsy required, (0) other facilities, one (1) CMMC and there were no (0) CECs in the parish for December.

Dr. Mark Haynes gave an update on CMMC and the clinics. Flu is rampant and COVID cases are on an upswing. They are seeing RSV cases, but mainly in younger patients. Dr. Mark Haynes recommended that if you haven't had your flu shot that it's not too late to get one.

President Scott Davidson told the Jury and those in attendance that if you go to the ER at CMMC to please, be patient if you must sit for a while. The staff is seeing a lot more patients right now than normal and they are doing the best they can.

CMMC CEO Tina Haynes thanked President Scott Davidson for his comment. The ER is seeing three times the normal patients count through the ER currently. The hospital has been full of sick patients, and they are doing everything they can see those sick individuals in a timely manner.

#### **Public Comments:**

President Scott Davidson told the Jury that he believes that consolidation of the water systems within the parish is inevitable and that failing to do so with other neighboring systems could possibly cause the failure of both of those systems. The cost of presently drilling a new potable water well for residential consumption by a system is well over \$400,000 and rising and with grant monies drying up at the state level, the ability to fund these repairs is becoming a losing battle.

Mrs. Destiny Hightower of the Claiborne Parish 4-H gave an update on the 2023-2024 Club enrollment increased from 192 Members and Volunteers to this year 343 Volunteers and members throughout our schools.

Claiborne Parish Director of Libraries Pam Suggs who is a resident of Lisbon, echoed President Davidson's comments and stated that she was proud of the fact that her water system Lisbon and

the Middle Fork Water System were the first to consolidate in the parish and that they were able to drill a new well and the water is wonderful. Mrs. Suggs also stated that there will be a Microsoft workshop on the  $26^{th}$  at the library if anyone needs assistance on working their cellphones or tablets.

President Scott Davidson introduced the 2 new jurors - District #1 Larry Ford and District #8 Malcolm Cooper.

Vice-President Mark Furlow introduced Warden Michelle Dauzat from David Wade Correctional.

Upon motion by Mark Furlow, duly seconded by Paul Cook, the meeting was adjourned.
