Under the 2019 LPSC Public Entity Energy Efficiency Program, the Claiborne Parish Police Jury has been awarded \$62,380 in energy grant money to help seal ductwork and make buildings more efficient and help lower energy costs. Commissioner Campbell also noted that the Town of Homer (\$150,000) and the Claiborne Parish School Board (\$300,000) has also been awarded grant money.

### ORDINANCE NO. 786

AN ORDINANCE ADOPTING AN OPERATING BUDGET OF REVENUE AND EXPENDITURES FOR THE FISCAL YEAR BEGINNING JANUARY 1, 2020 AND ENDING ON DECEMBER 31, 2020

BE IT ORDAINED by the Police Jury of Claiborne Parish, Louisiana, in a regular called session, the Ordinance adopting an Operating Budget for Revenues and Expenditures for the fiscal year beginning January 1, 2020 and ending December 31, 2020.

### ORDINANCE NO. 787

AN ORDINANCE ADOPTING AND ENACTING A NEW CODE FOR CLAIBORNE PARISH, LOUISIANA; PROVIDING FOR THE REPEAL OF CERTAIN ORDINANCES NOT INCLUDED THEREIN; PROVIDING A PENALTY FOR THE VIOLATION THEREOF; PROVIDING FOR THE MANNER OF AMENDING SUCH CODE; AND PROVIDING WHEN SUCH CODE AND THIS ORDINANCE SHALL BECOME EFFECTIVE.

# BE IT ORDAINED BY THE CLAIBORNE PARISH POLICE JURY:

<u>Section 1.</u> The Code entitled "Code of Ordinances, Claiborne Parish, Louisiana," published by Municipal Code Corporation, consisting of chapters 1 through 102, each inclusive, is adopted.

Section 2. All ordinances of a general and permanent nature enacted on or before January 11, 2017, and not included in the Code or recognized and continued in force by reference therein, are repealed.

Section 3. The repeal provided for in section 2 hereof shall not be construed to revive any ordinance or part thereof that has been repealed by a subsequent ordinance that is repealed by this ordinance.

Section 4. Unless another penalty is expressly provided, every person convicted of a violation of any provision of the Code or any ordinance, rule or regulation adopted or issued in pursuance thereof shall be punished by a term of imprisonment of up to thirty (30) days in the parish jail or a fine of not exceeding five hundred dollars (\$500.00) or both. Each act of violation and each day upon which any such violation shall continue or occur shall constitute a separate offense. The penalty provided by this section, unless another penalty is expressly provided, shall apply to the amendment of any Code section, whether or not such penalty is reenacted in the amendatory ordinance. In addition to the penalty prescribed above, the Parish may pursue other remedies such as abatement of nuisances, injunctive relief and revocation of licenses or permits.

Section 5. Additions or amendments to the Code when passed in such form as to indicate the intention of the parish to make the same a part of the Code shall be deemed to be incorporated in the Code, so that reference to the Code includes the additions and amendments.

<u>Section 6.</u> Ordinances adopted after January 11, 2017, that amend or refer to ordinances that have been codified in the Code shall be construed as if they amend or refer to like provisions of the Code.

At this time, Claiborne Parish Coroner, Dr. Mark Haynes, gave an update of the Coroner's Office. There were 16 total deaths in the parish in December. (6 Hospice/ER related), (3) required autopsies, (1) was an on scene. There were only (2) CEC's in the parish.

President Scott Davidson read aloud, a letter from James Hatch, who lives at 125 WPA Road in Athens, LA. In his letter Mr. Hatch stated that his trash can had been hit by a car on 2 different occasions and voiced his concerns with the cost these cans to the tax payers of Claiborne Parish. Mr. Hatch asked the Police Jury to caution the trash pickup crews and to encourage them not to place cans right on the side of the road.

Mr. David Green of Republic Waste told the Jurors that he would see to it that this is addressed with his crews and that the operating procedure is to place the empty cans 2-3 ft off of the road.

Rev. Willie Young also voiced his concern to Mr. David Green of problems of trash not being picked up in certain areas of his district in a timely manner. Mr. David Green told Rev. Willie Young that he would investigate this further and find out exactly the details of why the trash wasn't picked up on these locations and make sure this is corrected.

In closing, President Scott Davidson, informed the audience that the Jury feels that the future of our present structure and cost of our weekly curb-side garbage pickup in the unincorporated areas of Claiborne Parish is a major concern. The cost of garbage pickup has continued to increase while the revenues generated by the 1% sales tax collected in the rural areas of the Parish (outside the incorporated areas of Homer and Haynesville) is not covering the yearly expenditures of the garbage pickup by nearly \$150,000 annually. President Davidson told those in attendance that the citizens of Claiborne Parish need to be considering whether or not they will want to continue curb service pickup of trash or not in the near future. If they do, there will be some type of cost involved with it.
