The Road Committee met in the Conference Room of the CPPJ at 9:00 a.m.

At this time, President Scott Davidson presented the one item that was recommended from the Road Committee.

Upon motion by Kevin Gray, duly seconded by Mark Furlow, the Jury unanimously approved the purchase of a new copier for the Police Jury Administrative Office in the state contract amount of \$3,615.

At this time Claiborne Parish Coroner Dr. Mark Haynes gave the January 2024 repot for the Coroner's Office. There were nineteen (19) total deaths: ten (10) hospice/ER related, (0) other facilities, two (2) were on scene no autopsy required, one (1) on scene requiring autopsy, six (6) at CMMC and there were four (4) CECs in the parish for the month.

Dr. Mark Haynes, CMMC Medical Director, gave an update of the illnesses being seen in the clinics and in the ER at CMMC. He stated there has been an uptick of covid cases, where, most, have been minor symptoms, however, there have been many who have been hospitalized from other illnesses with COVID. The flu has been on the decline. This year, the flu cases that were seen, were severe cases. Not many flu cases being seen, in the past week. President Scott Davidson, along with Dr. Mark Haynes, reiterated the importance of getting your annual flu shot.

At this time, President Scott Davidson, along with the other Jurors, welcomed Tax Assessor Elect Katie Coburn and newly appointed Registrar of Voters Tracy Lowrey. Ms. Lowrey was chosen from five candidates to fill the vacancy due to the retirement of Mrs. Patricia Sanders.

Newly Appointed ROV Tracy Lowrey thanked the Jury for their confidence in her for the job. She is looking forward to working with them as the new Registrar of Voters and knows it will be hard to replace Mrs. Patricia Sanders who has had almost 40 years of service.

Mr. John Monzingo of the Claiborne Parish 4-H & LSU AgCenter updated the Jury on their upcoming events. 4-H Challenge Camp is upcoming later in the month that many of our 4-H kids will be attending. 4-H Regional Shooting Sports will be kicking off in in March.
