A RESOLUTION REQUESTING HELP FROM THE CLAIBORNE PARISH STATE LEGISLATORS CONCERNING THE AMOUNT OF PROPERTIES BEING ADJUDICTED TO THE CLAIBORNE PARISH POLICE JURY ON AN ANNUAL BASIS OF WHICH THE CLAIBORNE PARISH POLICE JURY HAS NO TAX INTEREST IN

WHEREAS, the Louisiana Revised Statutes requires the adjudication to the Parish immovable property on which the property taxes were not paid and which the property was not purchased at the subsequent tax sale; and

WHEREAS, once the property is adjudicated to the Parish, it will not come up for another tax sale; and

WHEREAS, the adjudicated property can only be redeemed (back in the name of the tax debtor), or sold by the Parish with clear title through an expensive and ineffective abandoned adjudicated process (such as Civic Source) or declared needed by the Parish for Public purposes; and

WHEREAS, the vast majority of these abandoned properties that are being adjudicated to the Parish for non-payment of taxes are overgrown lots and derelict homes that are located within the incorporated limits of the Towns of Homer and Haynesville and are exempt from Parish taxes under the current La Homestead Exemption laws and only subject to municipal property tax at the time of non-payment and adjudication; and

WHEREAS, the Parish has NO tax interest in the properties but is expected to upkeep and maintain these abandoned adjudicated properties to an extent that they are not deemed to be a public health or safety hazard to neighboring homes and residents; and WHEREAS, five years ago the Parish had less than 10 (ten) of these abandoned adjudicated properties and now that number stands at 65 (sixty-five) after the 2020 tax sale; and

WHEREAS, this issue has not only become a financial burden to Claiborne Parish but also to our neighboring parishes and to all rural parishes throughout the State;

BE IT HEREBY RESOLVED that the Claiborne Parish Police Jury REQUESTS of our Claiborne Parish Legislative Delegation to address this growing problem and to formulate a plan that is equitable, efficient and cost effective for selling/redeeming abandoned adjudicated property and issuing a clear merchantable title on said property.

Upon motion by Paul Cook, duly seconded by Gil Dowies, the Jury unanimously approved, upon recommendation of the Roads Committee, the Police Jury's new cell phone reimbursement policy that the Jurors and other named essential personnel will qualify for a monthly reimbursement or per diem in amount of \$60 per month for being enrolled in the Parish and State's Emergency Responder Cell Phone Service/Plan. Currently that plan is with FirstNet through AT&T.

Upon motion by Kevin Gray, duly seconded by Mark Furlow, the Jury unanimously approved, upon recommendation from the Roads Committee, the replacement of the ROV and District Attorney (\$51,360), and the CID building roofs (\$100,599). The work will be done by Brazos Industries out of Baton Rouge, LA.

Additional Public Comments:

Dr. Mark Haynes gave an update on the ongoing COVID-19 pandemic. He stated that the cases have greatly improved since December and that there were only between 3 or 4 cases currently in the hospital. The CMMC ICU has been at full capacity some of these ICU patients were COVID cases however most were not. Our hospital has been able to help out neighboring hospitals with helping to house patients. COVID vaccinations are becoming more widespread. Dr. Haynes recommends that if you fall into the Phase age groups, to get your vaccination. He also stated that if you feel like you are not sure, check with your doctor and see if he feels it is safe for you to do so. Dr. Mark closed his comments by telling those in attendance that while things have improved, we are still in a serious medical crisis and now is not the time to drop our guard. He also stated that as soon as his family members qualify to receive their vaccinations, they will receive the shot as well.

CMMC CEO Tina Haynes gave her monthly update on the hospital. She stated, the hospital is receiving vaccinations on a regular basis. Right now, age groups are 65 years and older, who are eligible to receive their shot. CMMC has reached out to all of the area churches, schools, etc. They are keeping an ongoing list of those requesting the vaccines. Mrs. Haynes updated jurors on the Opioid Unit that is slated to be licensed on Friday and open for business on Monday. Mrs. Tina Haynes expressed her gratitude and thank to our District #11 Representative Patrick Jefferson, who has made calls and worked hard to help get this unit opened. Mrs. Haynes stated that Representative Jefferson is a great friend of CMMC and he does a lot for our community. She told the Jurors that the Judges and DA have reached out to her wanting to know when they will be able to send individuals that qualify to the CMMC Opioid Unit. Mrs. Haynes stated that she hopes to be expanding the unit within 6 months with the need for this type of care. We are excited to open this part of CMMC. This unit will begin with inpatient services and expand to outpatient services.

Agent John Monzingo gave an update on the happenings in AgCenter and 4-H office and the upcoming events in the parish – including the Fern Sale, Shooting Sports and Master Gardener offerings.
