The Claiborne Parish Police Jury met in regular session in the Jury Chambers of the Claiborne Parish Police Jury Complex, located at 507 West Main Street in Homer, LA at 10:00 a.m. on the 8th of June. On being called to order by President, Scott Davidson, the following Jurors were present:

James Laird, Mark Furlow, Kevin Gray, Mary McDaniel. Paul Cook, Joseph Merritt, Jr., Tommy Sanders, and Gill Dowies.

District Ten Juror Rev. Willie Young, Sr. was absent due to a conflict with the La Minerals Board meeting in Baton Rouge.

There were 11 others in attendance which included Secretary-Treasurer Dwayne R. Woodard, Sheriff Sam Dowies, Claiborne Memorial CEO Tina Haynes, Mr. Jimmy Hand of Main Street, OEP Director Dennis Butcher, District Attorney Danny Newell, Library Director Mrs. Pam Suggs, Library Historian Mr. Wesley Harris, CA Baseball Head Coach Mr. Rayne Lewis, along with the CA MAIS 2022 AAA Champion Baseball team members, Ms. Jackie Tripp of Guardian Journal and Mr. Mark Crenshaw of Homer.

There was a Road Committee Meeting held at 9:00am in the Police Jury Conference Room.

President Scott Davidson called the meeting to order.

The meeting was opened with a word of Prayer led Joe Merritt, followed by the Pledge of Allegiance led by Paul Cook.

Upon motion by Kevin Gray, duly seconded by Mary McDaniel, the Jury unanimously voted to adopt the Regular Agenda as presented.

Upon motion by Kevin Gray, duly seconded by Mark Furlow, the Jury unanimously voted to amend the agenda and add the following:

1. Appoint Mrs. Nicole Wate of 1142 Price Drive, Haynesville, LA to fill the vacant board seat of CPHDS #3 due to the resignation of Mrs. Angela Kennedy. This appointment is effective immediately. This seat represents Districts 1 & 2 in Claiborne Parish.

Upon motion by Mark Furlow, duly seconded by Gil Dowies, the Jury unanimously approved a Special Resolution Honoring the Claiborne Academy 2022 MAIS AAA State Championship.

SPECIAL RESOLUTION

A Special Resolution in Honor and Recognition of the Claiborne Academy Rebels Winning the MAIS Class AAA State Baseball Championship on Thursday, May 19, 2022.

WHEREAS the Claiborne Parish Police Jury wishes to recognize the Claiborne Academy Rebels baseball team for winning the 2022 Class AAA MAIS Championship against Manchester Academy by a score of 9-3 which clinched the championship series two games to none and capped a 25-2 championship season; and

President Scott Davidson reminded the Jurors that our July 2022 Meeting will be held on Wednesday, July 13, 2022, at 10:00 am, due to the 4th of July holiday.

President Scott Davidson read aloud a notice that the La DA Employees Retirement System employer rate for the fiscal year July 1, 2022, to June 30, 2023, will remain at 9.5% and the employee rate will remain at 8.00%.

Upon motion by Gil Dowies, duly seconded by Mary McDaniel, the Jury unanimously approved the request from Secretary-Treasurer, Dwayne Woodard to re-appoint The Guardian Journal as the Official Journal of the Claiborne Parish Police Jury for the period of July 1, 2022, through June 30, 2023, since it is the only publication that meets the requirements as defined by La R.S.43:150 and La R.S. 43:174.

Upon motion by Kevin Gray, duly seconded by Joe Merritt, the Jury unanimously voted to allow Secretary-Treasurer Dwayne Woodard, to work with the PJAL and set the date for the upcoming Police Jury Region 4 Meeting, which will be held in Claiborne Parish this fall.

BE IT RESOLVED, by the Claiborne Parish Police Jury, that the Jury after consideration of the recommendation of the Main Street Homer Program, hereby approves participation of municipal addresses **515 East Main Street, Homer LA** owned by **511 South Main Enterprises, LLC** and further identified by the State Board of Commerce and Industry as application number **RTA #2019-03188** the Property Tax Abatement Program authorized by Act 445 of 1983 and Article VII Section 2(H) of the Constitution, effective February 5, 2020; therefore

Upon motion by James Laird, duly seconded by Kevin Gray, the Jury unanimously approved the hardship request for driveway repairs from Mrs. Mark Soister at 714 John Kelly Rd, Lillie, LA. Mr. Soister meets all the physical and income requirements.

Upon motion by Kevin Gray, duly seconded by Paul Cook, the Jury unanimously approved the request from Parish Road Superintendent Tommy Durrett, to advertise for bid for the purchase of a 2022 or newer Road Grader for use by the CPPJ Hwy Department.

At this time President Scott Davidson presented the Road Committee items.

Upon motion by Kevin Gray, duly seconded by Mark Furlow, the Jury upon recommendation from the Road Committee, unanimously denied the request from Silverside Timber for the Parish to dismiss the \$1,000 Fine for not obtaining an annual Heavy Hauler Permit in Claiborne Parish.

Upon motion by Tommy Sanders, duly seconded by Gil Dowies, the Jury, upon recommendation from the Road Committee, unanimously denied the request from Ewing Timber Co, for the Parish to dismiss the \$1,000 fine for not obtaining a site permit with Claiborne Parish.

Upon motion by Gil Dowies, duly seconded by Tommy Sanders, the Jury, upon recommendation from the Road Committee, unanimously adopted the Claiborne Parish Police Jury Employee Post Accident (non-Workers Comp related) Drug Testing Policy.

Upon motion by Mark Furlow, duly seconded by Kevin Gray, the Jury, upon recommendation from the Road Committee, adopted the Claiborne Parish Police Jury Accident Reporting Policy, which states that ANY employee involved in an accident involving any parish owned vehicle/equipment/property must notify the proper authorities (CPSO, LSP etc.) at the time of the accident.

Upon motion by Mary McDaniel, duly seconded by Kevin Gray, the Jury, upon recommendation from the Road Committee, adopted the new Change in Insurance Form for all Employees. All change request forms must go thru Secretary-Treasurer Dwayne Woodard and Asst. Secretary-Treasurer Mrs. Shelia Washington.

Parish Coroner Dr. Mark Haynes could not attend today's meeting, due to his covering the CMMC Emergency Room today. He will present his report at the July Police Jury Meeting.

Claiborne Memorial Medical Center CEO Mrs. Tina Hayne gave an update on the hospital. She stated there were no COVID patients admitted, at this time. However, Mrs. Haynes told the Jury that the clinics were seeing patients with COVID and that had very mild symptoms. She stated that most of the cases, seen in Claiborne Parish were from those who have traveled and returned with it.
