The Claiborne Parish Police Jury met in regular session in the Jury Chambers of the Claiborne Parish Police Jury Complex, located at 507 West Main Street in Homer, LA at 10:00 a.m. on the 13th of September 2023. On being called to order by President, Scott Davidson, the following jurors were present:

James Laird, Mark Furlow, Kevin Gray, Mary McDaniel, Paul Cook, Joseph Merritt, Jr., Tommy Sanders, and Gil Dowies.

District 10 Juror, Willie Young, Sr. was absent due to a conflict with a Mineral Board Meeting in Baton Rouge.

There was a Road Committee Meeting held at 9:00 a.m. in the Conference Room.

President Scott Davidson called the meeting to order.

The meeting was opened with a word of Prayer led Joseph Merritt, followed by the Pledge of Allegiance led by Paul Cook.

Upon motion by Gil Dowies, duly seconded by Joseph Merritt, the Jury unanimously voted to adopt the Regular Agenda as presented.

Upon motion by Kevin Gray, duly seconded by Mary McDaniel, the Jury unanimously voted to amend the regular agenda and add the following items.

Regular Agenda

President Scott Davidson reminded everyone that all Parish Employees are required to complete one (1) hour of ethics training by December 31, 2023.

President Scott Davidson also reminded everyone that one (1) hour of Preventing Sexual Harassment training is required to be completed by December 31, 2023, by all parish employees – Department Heads and Jury Officers have a two (2) hour training requirement.

President Scott Davidson read aloud a notice that Caddo Parish is hosting the Region IV PJAL Meeting that will be held on Wednesday evening, September 27, 2023; at The Petroleum Club at 6:00 pm. Please see Leigh Ann Sanders to RSVP.

President Scott Davidson read aloud a notice that the CPPJ has called a hearing to request input from the public about its annual plan that discusses the Mission, Goal, and Objectives of the Section 8 Housing Assistance Programs administered by the CPPJ. The hearing will be held on Tuesday, September 19, 2023, at 1:00 pm at the Section 8 Office located at 621 South Main Street, Homer, LA 71040.

President Scott Davidson read to the Jury, the receipt of the annual notice of the Parish's current balance with the Federal Off-System Highway Bridge Program is \$-45,625 as per letter received from the LADOTD dated August 21, 2023.

President Scott Davidson read aloud letters received on August 28, 2023, Official Notice of Act 397 of the 2023 Regular Legislative Session concerning State Aid to Local Government Entities the Police Jury was notified of the following awards - \$100,000 new roof for the PJ Admin Bldg, \$40,000 for a waterline extension Pinehill Water System on E D White Road, \$50,000 for the Haynesville Branch of the Claiborne Parish Library, \$50,000 for road repairs of E D White Road, \$50,000 for road repairs or water and sewer repairs within Senate District 36 and \$10,000 for waterline extension on Ponderosa Road.

President Scott Davidson read aloud a letter received on August 28, 20203, the CPPJ has been awarded a 2022-2023 LGAP award of \$100,000 for the roof repairs at the CPPJ Admin Bldg located at 507 West Main St. in Homer, LA.

Upon motion by Gil Dowies, duly seconded by Paul Cook, the Jury unanimously voted to leave the regular meeting and enter the Public Hearing for the 2023 Board of Review.

At this time, the presentation of the assessment of property values for the 2023 property tax rolls was given. The total Assessed Value of property in Claiborne Parish for the tax year 2023 is \$139,396,763 of which \$20,115,139 is Homestead Exempted property.

Tax Assessor Bob Robinson stated there have been no formal objections to the assessments other than one communications tower company which has been resolved. He has received no formal appeals by phone, email, or in person reported to his office.

Secretary-Treasurer Dwayne Woodard stated there have been no objections reported to his office via email, telephone, mail, or in-person regarding the 2023 Tax Assessment figures.

Upon motion by Kevin Gray, duly seconded by James Laird, the Jury voted to leave the Public Hearing for the 2023 Board of Review and return to the regular meeting of the Claiborne Parish Police Jury.

Upon motion by Kevin Gray, duly seconded by Mark Furlow, the Jury unanimously accepted the assessment of property values for the 2023 property tax rolls.

Upon motion by Gil Dowies, duly seconded by Mary McDaniel, the Jury unanimously adopted Resolution 2023-017 – A Resolution Levying Millage for the 2023 Tax Roll for the Claiborne Parish Police Jury.

RESOLTUION 2023-018 CERTIFICATE OF CLAIBORNE EVIDENCING PUBLIC APPROVAL OF BONDS PURSUANT TO SECTION 147(f) OF THE INTERNAL REVENUE CODE OF 1986, AS AMENDED

WHEREAS, the Capital Area Finance Authority (the "Authority"), a public trust created pursuant to the provisions of Chapter 2-A of Title 9 of the Louisiana Revised Statutes of 1950, as amended (R.S. 9:2341-9:2347, inclusive) (the "Act") has, by resolution dated September 19, 2023, in accordance with the requirements of the Act, and the Rules and Regulations of the Louisiana State Bond Commission (the "Commission"), duly authorized the issuance of not exceeding of Capital Area Finance Authority Revenue Bonds in one or more series (the "Bonds") to finance loans to first-time homebuyers within the jurisdictional parishes of the Authority and such other governmental units (the "Participating Jurisdictions") whose governing authority authorized and directed the execution of a cooperative endeavor agreement (a "CEA") with the Authority under the provisions of the Act and other applicable constitutional and statutory authorities; and

WHEREAS, the Commission, on August 17, 2023, duly authorized the issuance and sale of the Bonds in accordance with law and the Commission's Rules and Regulations; and

WHEREAS, the Bonds are classified as exempt facility bonds under the provisions of the Internal Revenue Code of 1986, as amended (the "Code") and the provisions of Section 147(f)(2)(A), (B) and (E) of the Code require that issuance of the Bonds be approved by the "applicable elected representative" of the governmental unit which issues such bonds or on whose behalf such bonds are issued and by the "applicable elected representative" of such other Participating Jurisdictions that have executed a CEA with the Authority under the provisions of the Act; and

WHEREAS, (the "Governmental Unit") has executed a CEA with the Authority to permit the financing of loans to first-time homebuyers within geographic area of the Governmental Unit; and

WHEREAS, the applicable elected representative (the "**Approving Representative**") of the Governmental Unit for purposes of approving the Bonds is the H. Scott Davidson/Parish President and

WHEREAS, in compliance with the requirements of the Code, Notice of Public Hearing (attached as Exhibit "A" hereto), was published in (i) The Advocate, Baton Rouge, Louisiana on September 8th, 2023, (ii) The Daily Advertiser, Lafayette, Louisiana on September 8th, 2023, (iii) the Houma Courier, Houma, Louisiana on September 8th, 2023, (iv) the Lake Charles American Press, Lake Charles, Louisiana on September 8th, 2023, (v) The News Star, Monroe, Louisiana on September 8, 2023, (vi) the Times-Picayune, New Orleans, Louisiana on September 8th, 2023, (vii) The Times, Shreveport, Louisiana on September 8th, 2023, and (viii) The Town Talk, Alexandria, Louisiana on September 8th, 2023, and

WHEREAS, in compliance with the requirements of the Code, the public hearing with respect to the issuance of said Bonds was held on September 18, 2023, at 1:00 p.m., Louisiana Time, at 601 St. Ferdinand Street, Baton Rouge, LA 70802, and simultaneously held by teleconference with a toll-free number 1-888-475-4499 and guest access code 994-030-3250 in accordance with Rev. Proc. 2022-20 after due notice thereof was published in the official journal of the Authority and in the aforementioned publications sufficient to inform the public within the geographic area of the Participating Jurisdictions of the subject, date and place of said public hearing; and

WHEREAS, no objections were raised by any person present at the said hearing or by any person participating by teleconference relative to the issuance of the Bonds; and

WHEREAS, the undersigned, Approving Representative of the Participating Jurisdiction, desires to approve the issuance of the Bonds for the purposes of the Code;

NOW, THEREFORE, the undersigned does hereby certify that the Chief elected executive officer/governing authority Governing authority of the Participating Jurisdiction, hereby approves, and confirms the issuance of the Bonds. The Authority, and its officers, are authorized to cause this certificate to be filed of record in the transcript of proceedings for the Bonds and to file a copy thereof with any State or Federal agency, board or commission as may be required by any applicable State or Federal laws, rules, or regulations.

WHEREAS, the Louisiana Revised Statute 18:532.1(B)(2)(a) states that precincts may be consolidated with adjacent precincts for the purpose of satisfying the requirement regarding the minimum number of registered voters per precinct;

NOW, THEREFORE BE IT ORDAINED by the Claiborne Parish Police Jury, that the following polling places are hereby designated, and election precincts are hereby created through the consolidation of certain existing election precincts and shall become effective for all purposes on the first day of December 2023, or upon receiving preclearance of said consolidation from the United States Department of Justice, whichever shall occur later.

SECTION 1: CLAIBORNE PARISH ELECTION PRECINCT NUMBER 10 AND ELECTION PRECINT NUMBER 11B ARE CONSOLIDATED INTO A SINGLE ELECTION PRECINCT NUMBER 10.

Polling Place shall be Lisbon Community Center at 131 Hebron Road in Lisbon, Louisiana.

{LEGAL DESCRIPTION OF NEW PRECINCT No.10} - Beginning at the junction of the center right-of-way of Louisiana State Highway 2 and the center flow channel of Middle Fork Bayou D'Arbonne, thence proceed northwesterly on said bayou to a point where the flow channel diverges into northern and southern flow ways in the Northwest quarter of Section 27, Township 22 North, Range 5 West, thence proceed easterly on the southern flow-way to its junction with the center flow channel of an unnamed creek on the eastern side of Section 18, Township 22 North, Range 5 West, thence proceed southwesterly on said creek to its junction with the center right-of-way of Richardson Loop; thence proceed southerly on said road to its junction with Louisiana State Highway 9 and Antioch Road; thence proceed southeasterly on the center right-of-way of Antioch Road to its junction with the center right-of-way of Greer Road; thence proceed southerly along said road to its junction with the center right-of-way of Louisiana State Highway 2, thence proceed westerly on said road to its junction with the center right-of-way of a road named Liberty Hill, then proceed southernly on said road until its junction with an unnamed road on the eastern side of Section 25, Township 21 North Range 6 West to its junction with the centerright of way of a pipeline, then proceed southeasterly on said pipeline to the northern shoreline of Lake Claiborne, thence proceed southeasterly on the northern shoreline of Lake Claiborne to its junction with the Lake Claiborne dam, thence proceed southeasterly on the dam to its junction with the center flow channel of Bayon D'Arbonne, then proceed easterly then northernly on said bayou to the boundary line between Claiborne Parish and Lincoln Parish, the proceed northernly then easterly on said boundary line until its junction with the center right-of-way of Tibbett Road, then proceed eastly along said road to its junction with the center right-of-way of Revis Fowler Road, hence proceed northeasterly on said road to its junction with the center right-of-way of Sharon Road, the proceed north on said road to its junction with the center right-of-way Louisiana State Highway 152, thence proceed northwesterly on Louisiana State Highway 152 to the junction of the center right-of-way of Louisiana State Highway 2, the point of beginning.

NOW, THEREFORE BE IT ORDAINED by the Claiborne Parish Police Jury, that the following polling places are hereby designated, and election precincts are hereby created through the consolidation of certain existing election precincts and shall become effective for all purposes on the first day of December 2023, or upon receiving preclearance of said consolidation from the United States Department of Justice, whichever shall occur later.

SECTION 1: CLAIBORNE PARISH ELECTION PRECINCT NUMBER 85A AND ELECTION PRECINT NUMBER 88 ARE CONSOLIDATED INTO A SINGLE ELECTION PRECINCT NUMBER 88.

Polling Place shall be Homer City Hall at 400 East Main Street in Homer, Louisiana.

{LEGAL DESCRIPTION OF NEW PRECINCT No. 88}
