WHEREAS for 35 years from 1966 to 2000 Coach Red Franklin served as Head Coach of the Haynesville High School Golden Tornado football team.

WHEREAS during those 35 years Coach Franklin coached 450 games, amassing a record of 366-76-8 for a winning percentage of 81.33% which included 11 state titles, 4 runners-up and made the playoffs 31 out of 35 years with 8 perfect seasons.

WHEREAS Coach Red Franklin is one of the winningest high school football coaches in Louisiana and the country.

WHEREAS Coach Red Franklin was TWICE named National High School Athletic Association Region 5 Coach of the Year.

WHEREAS Coach Red Franklin has been recognized by numerous organizations including as a member of the Louisiana Sports Hall of Fame, Louisiana High School Coaches Association Hall of Fame, Louisiana Christian University (La College) Hall of Fame, Ark-La-Tex Sports Museum of Champions and the National Federation of State High School Associations Hall of Fame.

WHEREAS Coach Red Franklin is one of the most respected high school football coaches in the nation and the 4<sup>th</sup> all-time winningest head coach in LHSAA history (1<sup>st</sup> amongst public school schools) has represented his home of Claiborne Parish, Louisiana with distinction and pride.

WHEREAS Coach Franklin's many contributions and service to the youth of his community and parish and church may outweigh his many accomplishments on the field of play.

NOW, THEREFORE BE IT RESOLVED that the Claiborne Parish Police Jury hereby recognizes Coach Alton "Red" Franklin as a Louisiana Legend, truly one of Claiborne's Best and that it declares Saturday, October 21, 2023, to be "Coach Red Franklin Day" in Claiborne Parish, Louisiana.

NOW, THEREFORE BE IT ORDAINED by the Claiborne Parish Police Jury, that the following polling places are hereby designated, and election precincts are hereby created through the merging of certain existing election precincts and shall become effective for all purposes on the first day of December 2023.

SECTION 1: CLAIBORNE PARISH ELECTION PRECINCT NUMBER 10 AND ELECTION PRECINT NUMBER 11B ARE MERGED INTO A SINGLE ELECTION PRECINCT NUMBER 10.

Polling Place shall be Lisbon Community Center at 131 Hebron Road in Lisbon, Louisiana.

# AN ORDINANCE RENAMING ELECTION PRECINCT 84A TO 84 FOR CLAIBORNE PARISH, LOUISIANA

WHEREAS, the Louisiana Revised Statute 18:532.1(A) states that the parish governing authority shall have authority to change the configuration, boundaries, or designation of an election precinct;

NOW, THEREFORE BE IT ORDAINED by the Claiborne Parish Police Jury, that the following polling place is hereby designated, and election precinct is hereby created through the renaming of a certain existing election precinct and shall become effective for all purposes on the first day of December 2023.

SECTION 1: THE RENAMING OF CLAIBORNE PARISH ELECTION PRECINCT NUMBER 84A TO BE KNOWN AS CLAIBORNE PARISH ELECTION PRECINCT NUMBER 84.

Polling Place shall be Homer City Hall at 400 East Main Street in Homer, Louisiana.

# {LEGAL DESCRIPTION OF NEW PRECINCT No. 84}

Beginning at the junction of the center right-of-way of Cemetery Street and the center right-of-way of Edgewood Drive, thence proceed easterly on Edgewood Drive to the center right-of-way of U.S. Highway 79, thence proceed southerly on said highway to the center right-of-way of North Main Street, thence proceed easterly on North Main Street to the center right-of-way of East 4th Street, thence proceed northerly on said street to the center right-of-way of North 4th Street, thence proceed easterly on said street to the center right-ofway of East 5<sup>th</sup> Street, thence proceed southerly on said street to the center right-of-way of Louisiana State Highway 9, thence proceed northeasterly on said highway to the center flow channel of Bayou D'Arbonne, thence proceed southeasterly on said bayou to its junction with the electric power transmission line in Section 19 of Township 21 North, Range 6 West, thence proceed southerly, then southeasterly, then southeasterly, then southerly on said power transmission line to its junction with the center flow channel of Caney Creek, thence proceed westerly on said creek to the center right-of-way of Louisiana State Highway 146, thence proceed northerly on said highway to the junction with the center right-of-way of South 4th Street, thence proceed westerly on said street to the junction of the center right-of-way of Owens Street, thence proceed northerly on said street to the center right-of-way of Beardsley Avenue, thence proceed westerly on said avenue to the center right-of-way of East Main Street, thence proceed southerly on said street to the center right-of-way of South 6th Street, thence proceed westerly on said street to the center right-of-way of U.S. Highway 79, thence proceed northerly on said highway to the junction of the center right-of-way of Fulmer Street, thence proceed westerly on said street to the center right-of-way of West 3rd Street, thence proceed northerly on said street to the junction of the center right-of-way of Cemetery Street, thence proceed westerly then northerly on said street to the junction of the center right-of-way of Edgewood Drive, the point of beginning.

#### SECTION 2. POLLING PLACE OF PRECINCT 84

The Polling Place for Claiborne Parish Election Precinct 84 shall be the Homer City Hall at 400 East Main Street in Homer, Louisiana.

SECTION 3. PUBLICATION

A copy of this ordinance shall be published in one issue of the official journal of this Police Jury, as required by law.

#### SECTION 4. CONFLICTING PROVISIONS

# ANNUALCERTIFICATION OF COMPLIANCE WITH STATE OF LOUISIANA OFF SYSTEM BRIDGE REPLACEMENT PROGRAM

WHEREAS, the Code of Federal Regulations as enacted by the United States Congress mandates that all structures defined as bridges located on all public roads shall be inspected, rated for safe load capacity and posted in accordance with the National Bridge Inspection Standards and that an inventory of these bridges be maintained by each State, and

WHEREAS, the responsibility to inspect, rate and load post these bridges under the authority of Claiborne Parish in accordance with those standards is delegated by the Louisiana Department of Transportation and Development to Claiborne Parish.

NOW, THEREFORE BE IT RESOLVED, by the governing authority of Claiborne Parish, Louisiana (herein referred to as the Parish) convened in Regular Session on the 6<sup>th</sup> day of October 2021, that it does hereby certify to the Louisiana Department of Transportation and Development (herein referred to as the DOTD) that for the period beginning October 1, 2022, and ending September 30, 2023.

1. The Parish has performed and will continue to perform all interim inspections on all Parish owned or maintained bridges in accordance with the National Bridge Inspection Standards.

- 2. All bridges owned or maintained by the Parish have been structurally analyzed and rated by the Parish as to the safe load capacity in accordance with AASHTO Manual for Maintenance Inspection of Bridges. The load posting information that has been determined by the LA DOTD for all bridges where the maximum legal load under Louisiana State law exceeds the load permitted under the operating rating as determined above has been critically reviewed by the Parish. Load posting information has been updated by the Parish to reflect all structural changes, and obsolete structural ratings or any missing structural ratings.
- 3. All Parish owned or maintained bridges which require load posting or closings are load posted or closed in accordance with the table in the DOTD Engineering Directives and Standards Manual Directive No. 1118. All DOTD supplies load posting information concerning a bridge has been critically reviewed by the Parish Road Superintendent Prior to load posting.
- 4. All bridges owned or maintained by the Parish are shown on the attached list in the format specified by the DOTD. Corrections to data supplies to the Parish by the LA DOTD are noted.

These stipulations are prerequisites to participation by the Parish in the Off-System Bridge Replacement Program.
