The Claiborne Parish Police Jury met in regular session in the Jury Chambers of the Claiborne Parish Police Jury Complex, located at 507 West Main Street in Homer, LA at 10:00 a.m. on the 15th of November 2023. On being called to order by President Scott Davidson, the following Jurors were present:

There was a Road Committee Meeting held at 9:10 a.m. in the Police Jury Conference Room.

President Scott Davidson called the meeting to order.

The meeting was opened with a word of prayer led by Rev. Willie Young, followed by the Pledge of Allegiance led by Paul Cook.

Upon motion by Kevin Gray duly seconded by Paul Cook, the Jury unanimously voted to adopt the Regular Agenda as presented.

Upon on Motion of Tommy Sanders, duly seconded by Paul Cook the Jury voted unanimously to amend the agenda and add the following items to the agenda:

At this time, President Scott Davidson asked the Jury if they would act up the two (2) amendments to the agenda.

President Scott Davidson read aloud a notice that the 2023-2024 CWEF/LGAP application portal is open from November 1, 2023, until February 29, 2024.

Upon motion be Mark Furlow, duly seconded by Kevin Gray, the request from Northwest La. Human Services District, in a letter received on November 10, 2023, requesting that the Police Jury appoint someone to replace Don Pledger who resigned on November 8, 2023, was tabled for the present time. The Jury will seek a recommendation from CMMC CEO Tina Haynes one who she feels can fill that role.

## Regular Agenda

President Scott Davidson read aloud a notice that all Parish Employees are required to complete one (1) hour of ethics training by December 31, 2023.

President Scott Davidson reminded everyone that one (1) hour of Preventing Sexual Harassment Training is required to be completed by December 31, 2023, by all parish employees – department heads and Jury officers have a two (2) hour training requirement.

President Scott Davidson read aloud a reminder - 2023 Thanksgiving Holiday – lunch Tuesday, November 21st at the Road Barn on Hwy 2, off Wednesday November 22nd through Friday the 24th – return to work on Monday, November 27th, 2023.

President Scott Davidson read aloud a reminder - 2023 Christmas Holiday – lunch Thursday, December 21st at the Road Barn on Hwy 2, off Friday the 22nd through Monday, January 1st, return to work on Tuesday January 2nd, 2024.

President Scott Davidson read aloud a notice of award, per a letter received from the Governor's Office on October 26, 2023, the Police Jury has been awarded a 2022-2023 CWEF Grant in the amount of \$100,000 for the South Claiborne Water System Owens Booster Station Project.

Upon motion by Kevin Gray, duly seconded by Gil Dowies, the Jury unanimously adopted Resolution 2023 - 022 - A Resolution Providing for the Canvassing the Returns and Declaring the Results of the Special Election held in Parish of Claiborne on Saturday, October 14, 2023 (Building Maintenance Renewal)

The following resolution was offered by Kevin Gray and seconded by Gil Dowies:

### **RESOLUTION 2023-022**

A resolution providing for canvassing the returns and declaring the results of the special election held in the Parish of Claiborne, State of Louisiana, on Saturday, October 14, 2023, to authorize the continuation of a special tax therein.

BE IT RESOLVED by Police Jury of the Parish of Claiborne, State of Louisiana (the "Governing Authority"), acting as the governing authority of the Parish of Claiborne, State of Louisiana (the "Parish"), that:

SECTION 1. <u>Canvass.</u> This Governing Authority does now proceed in open and public session to examine the official tabulations of votes cast at the special election held in the Parish of Claiborne, State of Louisiana, on SATURDAY, OCTOBER 14, 2023 (the "Election"), to authorize the continuation of a special tax therein pursuant to the following proposition (the "Proposition"):

## PROPOSITION (MILLAGE CONTINUATION)

Shall the Parish of Claiborne, State of Louisiana (the "Parish"), continue to levy a tax of 2.77 mills on all the property subject to taxation in the Parish (an estimated \$326,400 reasonably expected at this time to be collected from the levy of the tax for an entire year), for a period of 10 years, beginning with the year 2025 and ending with the year 2034, for the purpose of operating, repairing, maintaining and equipping the Parish Courthouse, the Parish Jail and other Parish Buildings, including paying the cost of utilities therefore, said millage to represent a .06

increase (due to reappraisal) over the 2.71 mills tax authorized to be levied through the year 2024 pursuant to an election held on October 19, 2013?

This Governing Authority does further proceed to examine and canvass the returns of the Election thereof.

SECTION 2. <u>Election Results.</u> According to the official certified tabulation of votes cast at said Election, there was a total of **2,599** votes cast **IN FAVOR OF** Proposition and a total of **1,339** votes cast AGAINST Proposition, resulting in a majority of **1,260** votes cast **IN FAVOR OF** Proposition. The Proposition was therefore duly **CARRIED** by a majority of the votes cast by the qualified electors voting at the Election.

SECTION 3. <u>Promulgation of Election Result.</u> The results of said election shall be promulgated by publication in the manner provided by law, after receipt from the Secretary of State's office of the actual costs of the election, as required by §18:1292 of the Louisiana Revised Statutes of 1950, as amended.

SECTION 4. <u>Declaration</u>. The foregoing results of the Election are hereby declared by this Governing Authority and shall be published as required by law.

SECTION 5. <u>Procès Verbal</u>. A *Procès Verbal* of the canvass of the returns of the Election shall be made and a certified copy thereof shall be forwarded to the Secretary of State, Baton Rouge, Louisiana, who shall record the same in his office; another certified copy thereof shall be forwarded to the Clerk of Court and *Ex-Officio* Recorder of Mortgages in and for the Parish of Claiborne, who shall record the same in the Mortgage Records of said Parish; and another copy thereof shall be retained in the archives of this Governing Authority.

There was found by said count and canvass that there was a total of **2,599** votes cast **IN FAVOR OF** Proposition and a total of **1,339** votes cast **AGAINST** Proposition, as hereinabove set forth, and it was further found and determined that there was a majority of **1,260** votes cast **IN FAVOR OF** Proposition as hereinabove set forth.

Therefore, the Governing Authority did declare and proclaim and does hereby declare and proclaim in open and public session that the Proposition as hereinabove set forth was duly **CARRIED** by a majority of the votes cast by the qualified electors voting at the said special election held in the Parish on Saturday, October 14, 2023.

### PROPOSITION (MILLAGE CONTINUATION)

Shall the Parish of Claiborne, State of Louisiana (the "Parish"), continue to levy a tax of 2.77 mills on all the property subject to taxation in the Parish (an estimated \$326,400 reasonably expected at this time to be collected from the levy of the tax for an entire year), for a period of 10 years, beginning with the year 2025 and ending with the year 2034, for the purpose of operating, repairing, maintaining and equipping the Parish Courthouse, the Parish Jail and other Parish Buildings, including paying the cost of utilities therefore, said millage to represent a .06 increase (due to reappraisal) over the 2.71 mills tax authorized to be levied through the year 2024 pursuant to an election held on October 19, 2013?

Said special election will be held at each and every polling place in the Parish of Claiborne, which polls will open at seven o'clock (7:00) a.m. and close at eight o'clock (8:00) p.m., in accordance with the provisions of La. R.S. 18:541.

Notice is further given that a portion of the monies collected from the tax described in the Proposition shall be remitted to certain state and statewide retirement systems in the manner required by law.

Upon motion by Paul Cook, duly seconded by Mary McDaniel, the Jury unanimously voted to begin the process of adding Lee Circle located in Sec 1 & Sec 12 of T23N R6W totaling approximately 0.26 miles of unimproved dirt road off Bailey Town Road to the Parish Road System. President Scott Davidson recommended that each of the 5 homeowners receive a letter of intension to place road back into the system.

Upon motion by Kevin Gray, duly seconded by Joseph Merritt, in an email received November 1, 2023, to issue a letter recognizing Claiborne Men in Action, as an organization which is based out of Claiborne Parish with the intentions of serving the Parish in a variety of charitable ways.

At this time President Scott Davidson presented the recommendations from the Road Committee.

Upon motion by Kevin Gray, duly seconded by Paul Cook, the Jury unanimously approved, the recommendation from the Road Committee for the installation of suspended heaters in the shop at the Road Barn. The estimated cost is \$9,600.

Upon motion by Gil Dowies, duly seconded by Tommy Sanders, the Jury unanimously approved the recommendation from the Road Committee to advertise thru ManPower for the position of a Mechanic Helper. This open was created when Mr. Kaden Williams accepted the position of Operator II.

Upon motion by Kevin Gray, duly seconded by Mark Furlow, the Jury unanimously approved the recommendation from the Road Committee for the purchase of a tire mount machine for the shop. The estimated cost is \$8,500.

At this time Claiborne Parish Coroner Dr. Mark Haynes gave his monthly report. There were a total of (20) deaths in the month of October: (11) ER/Hospice, (2) on scene with no autopsy, (3) requiring autopsy, (2) hospital, (2) in other facilities and (3) CEC's.
