MINUTES

Of the Regular Meeting, of The Claiborne Parish Police Jury 10:00 a.m. November 4, 2020 Police Jury Chambers 507 West Main Street Homer, LA 71040

The Claiborne Parish Police Jury met in regular session in the Jury Chambers of the Claiborne Parish Police Jury Complex, located at 507 West Main Street in Homer, LA at 10:00 a.m. on the 4th of November, 2020. On being called to order by President Scott Davidson, the following Jurors were present:

James Laird, Mark Furlow, Kevin Gray, Mary McDaniel, Joseph Merritt, Tommy Sanders, Gil Dowies, and Rev. Willie Young.

District #6 Juror Paul Cook was absent.

There were over 11 others in attendance which included, Secretary-Treasurer Dwayne R. Woodard, Parish Road Superintendent Tommy Durrett, Claiborne Parish Sheriff Sam Dowies, Claiborne Parish Coroner Dr. Mark Haynes, Claiborne Parish Director of Libraries Mrs. Pam Suggs, Claiborne Parish Library Historian Wesley Harris, OOCS Executive Director Tim Cain, CMMC CEO Tina Haynes, Parish Engineer Randal Smoak, Ms. Jackie Tripp of the Guardian Journal and Division A Judge Candidate Elect Walter May.

The meeting was opened with a word of Prayer led by Rev. Willie Young, followed by the Pledge of Allegiance led by Mark Furlow.

Upon motion by Tommy Sanders, duly seconded by Joseph Merritt, the Jury unanimously voted to adopt the Regular Agenda as presented.

Upon motion by Mary McDaniel, duly seconded by Mark Furlow, the Jury unanimously voted to amend the Regular Agenda and add the following:

This will be done on a reimbursement thru the Town's ad valorem tax credit.

Regular Agenda:

President Scott Davidson reminded all Jurors that they are required to complete one (1) hour of Ethics Training per year.

President Scott Davidson reminded all Jurors of the mandatory one (1) hour of Sexual Harassment Training required by December 31, 2019 for all Parish employees. Dept. Heads and Jury Officers are required to have two (2) hours of training.

Secretary-Treasurer Dwayne Woodard gave an update on the Police Jury Office of the day-to-day Parish Operations. The Police Jury and its offices are still working as close to normal operations as it can under Phase III of the Governor's Executive Order.

President Scott Davidson read aloud a notice that the CWEF and LGAP grant application deadlines are February 1, 2021.

Upon motion by Paul Cook, duly seconded by James Laird, the Jury unanimously awarded the lowest qualified bid for the HVAC sealing of the following parish owned properties -CPPJ Admin. Building, Claiborne Parish Clerk of Court, Claiborne Parish Tax Assessor, Claiborne Parish Courthouse, Claiborne Parish Office of Community Services, Claiborne Parish District Attorney's Office under the LPSC Energy Efficiency Grant to Southern Attic Solutions of Bossier in the amount of \$63,700 for all buildings. (The Public Safety Grant amount awarded to the Parish was \$62,380)

Upon motion by Mark Furlow, duly seconded by Kevin Gray, the Jury unanimously approved Resolution 2020 – 017- A Resolution for the Abandonment and Removing of a Portion of the Coon Hollow Road (Parish Road #164) from the Parish Road System.

A RESOLUTION TO ABANDON AND REMOVE A PORTION OF PARISH ROAD No. 164, COON HOLLOW ROAD, SITUATED IN SEC. 20, 21, 29 & 32 ALL IN T22N, R8W OF CLAIBORNE PARISH

WHEREAS, the Parish of Claiborne has deemed the entirety of Parish Road No. 164, Coon Hollow Road to be unmaintainable in its current condition and due to the increase of criminal activity and illegal dumping in the area, the Parish intends to abandon and remove a portion of Parish Road No. 164, Coon Hollow Road, from the Claiborne Parish Road System; and

WHEREAS, the Parish plans to abandon and remove the portion of the road beginning at a point approximately 0.4 miles north of the intersection of LA Hwy 534 to a point approximately 1.5 miles south of the intersection of PD Worley Road, a total of approximately 1.0 miles; and

WHEREAS, the section of road is not presently, nor will it be in the future, used for school bus pickup, trash pickup, and mail delivery; and

WHEREAS, the Claiborne Parish Police Jury will not continue to maintain the afore mentioned Parish Road No. 164; and

WHEREAS, the Claiborne Parish Police Jury, duly advertised and held a public hearing concerning proposed abandonment of the aforementioned portion of Parish Road No. 164, the Coon Hollow Road; and

NOW, THERE FOR BE IT RESOLVED, by the Claiborne Parish Police Jury in due, legal and regular session convened, that the Parish of Claiborne does hereby abandon the afore mentioned portion of Parish Road No. 164, the Coon Hollow Road, and will not maintain the said portion of the road in the future.

BE IT FURTHER RESOLVED, that this resolution shall take effect immediately.

activity and illegal dumping in the area, the Parish intends to abandon and remove the entirety of Parish Road No. 231, the English Road, from the Claiborne Parish Road System; and

WHEREAS, the Parish plans to abandon and remove the entirety of the road beginning at the intersection of LA Hwy 152 until its dead end, a total of approximately 0.2 miles; and

WHEREAS, the Claiborne Parish Police Jury will not continue to maintain the afore mentioned Parish Road No. 231; and

Upon motion by Tommy Sanders, duly seconded by Kevin Gray, the Jury unanimously approved the recommendation from the Road Committee, to upgrade the sound system at the Courthouse at an estimate amount of \$14,000.
