Of the Regular Meeting of The Claiborne Parish Police Jury 10:00 a.m. November 9, 2022 Police Jury Chambers 507 West Main Street Homer, LA 71040

The Claiborne Parish Police Jury met in regular session in the Jury Chambers of the Claiborne Parish Police Jury Complex, located at 507 West Main Street in Homer, LA at 10:00 a.m. on the 9th of November 2022. On being called to order by President Scott Davidson, the following Jurors were present:

Upon motion by Joseph Merritt, duly seconded by James Laird, the Jury unanimously approved, request from Road Superintendent Tommy Durrett in an email received 11/1/2022 requesting that CPPJ Hwy Dept Truck Driver Chauncey Williams be given a \$0.75/hour increase in base pay to \$15.33 and Kaden Williams be hired full-time with benefits as a Mechanic Helper at \$12.50/hour - both actions would be effective with the pay period starting November 10, 2022.

Upon motion by Mark Furlow, duly seconded by James Laird, the Jury unanimously approved, upon recommendation of the Road Committee, the new BCBS renewal rates and to move the annual renewal date to January 1st of each year. The was less than a 1% increase for the 2023 calendar year.

Parish Coroner Dr. Mark Haynes gave his update and the reports for September and October 2022.

There were (12) total deaths in September - (5) Hospital/ER, (2) requiring autopsies, (1) on-scene, (4) hospice, and (6) CEC's

There were (90 total deaths in October: (4) Hospital/ER, (0) requiring autopsy, (4) other, (1) onscene, and (3) CEC's.

CMMC CNO Mrs. Lee Jones gave an update on the hospital. The CMMC is full currently and on diversion. They are seeing a lot of RSV cases. The other hospitals in the area are also on diversion due to low staffs. Mrs. Jones stated that one of her stroke patients had to be sent to Little Rock due to no beds available in the area.
