Of the Regular Meeting, of The Claiborne Parish Police Jury 10:00 a.m. March 6, 2019 Police Jury Chambers 507 West Main Street Homer, LA 71040

The Claiborne Parish Police Jury met in regular session in the Jury Chambers of the Claiborne Parish Police Jury Complex, located at 507 West Main Street in Homer, LA at 10:00 a.m. on the 6<sup>th</sup> of March 2019. On being called to order by President, Scott Davidson, the following Jurors were present:

Upon motion by Kevin Gray, duly seconded by Mark Furlow, the Jury unanimously voted to adopt the Regular Agenda as presented.

Upon motion by Joseph Merritt duly seconded by Paul Cook, the Jury unanimously voted to amend the regular agenda add the following items:

President Scott Davidson requested that Dr. Mark Haynes be allowed to present the Coroner's report at this time, due to Dr. Mark needing to leave the meeting early.

Claiborne Parish Coroner, Dr. Mark Haynes, gave his update for the Coroner's Office. There were 14 deaths - (9) Hospice/ER related, (5) sent for autopsy and there were (3) CEC's. Dr. Mark also wanted to remind everyone that the flu seems to still be ongoing and it is not too late to get a flu shot.

## Regular Agenda

President Scott Davidson reminded all Jurors that they are required to complete 1 hour of Ethics Training per year.

President Scott Davidson reminded all Jurors that the field work for the Police Jury's annual audit would begin on April 8, 2019 with Bosch and Statham.

Upon motion by Paul Cook, duly seconded by Kevin Gray, the Jury unanimously approved, upon recommendation from the Road Committee, the awarding of the legally advertised bid (CPPJ-B2019-07) for the purchase of a 2019 Tri-Axle Dump Truck to Kenworth of LA in the amount of \$115,450 for the truck, along with 16 ft Davis Dump Bed at \$11,335 plus a motorized tarp cover which is approximately \$1,000.

Upon motion by Gil Dowies, duly seconded by Paul Cook, the Jury unanimously approved the presentation and adoption of the Claiborne Parish Police Jury's Sexual Harassment Policy as required by LA R.S. 42:342.

Upon motion by Kevin Gray, duly seconded by Mark Furlow, the Jury unanimously approved the 2019 Proposed Chip Seal List.

At this time, Paul Cook presented the Jury with requests from the Road Committee.

Upon motion by Paul Cook, duly seconded Kevin Gray, the Jury unanimously approved the request to pay one third of the cost – approximately \$3,500 to replace the back-up generator on the radio tower in Athens. (This cost will be shared with CPFD#5, CPSO, and CPPJ).

Upon motion by Mark Furlow, duly seconded by Kevin Gray, the Jury unanimously approved, upon recommendation from the Personnel Committee, the wage scale adjustment of Class C wage scale - Mechanic/Welder 5 years plus, to \$14.25 (low end) to \$17.75 per hour (high end) effective immediately.

Upon motion by Joseph Merritt, duly seconded by Tommy Sanders, the Jury unanimously approved purchasing a sponsor table in the amount of \$150 at the Claiborne Parish NAACP Banquet to be held on March 9, 2019.

President Scott Davidson read the Resolution of Memoriam Presented to the Family of Mr. Joe A. Sturges by the Police Jury Association of Louisiana. This resolution will be given to the family of the late Mr. Joe Sturges during the PJAL annual meeting in February.
