A RESOLUTION IN OPPOSITION OF ALL PROPOSED LEGISLATION THAT TRANSFERS THE ADMINISTRATION AND COLLECTION OF LOCAL SALES & USE TAXES TO THE LOUISIANA DEPARTMENT OF REVENUE.

RESOLUTION #2019-007

WHEREAS, the Constitution of the State of Louisiana grants local governments the right to levy and collect local sales and use taxes;

WHEREAS, there are several constitutional amendments and bills introduced in the 2019 Regular Legislative Session that would transfer collection responsibility of local sales and use tax levies to the state Department of Revenue; and

WHEREAS, local taxing authorities possess the best knowledge and experience to properly collect its own taxes and have a proven record of proactive advancements in the areas of enforcement, audit coverage, dispute resolution, reporting technology and successful litigation; and

WHEREAS, the state of Louisiana's budget issues do not offer prospects for the Department of Revenue to have sufficient resources to provide the necessary taxpayer assistance, enforcement programs and training of its employees on the specific application or local sales and use tax ordinances without significant cost contributions from local governments, thereby resulting in the direct and indirect loss of local tax receipts; and

WHEREAS, many local taxing authorities have issued bonded indebtedness guaranteed by the passage locally adopted sales and use tax levies, collection of said levies the direct responsibility of local governments, and which transfer of that responsibility to a state agency may generate legal challenges and jeopardize future bond issues; and

WHEREAS, the central local collector in each parish is directly responsible to the local taxing authorities and their elected officials for the performance of local tax administration, and the Secretary Revenue being an appointee of the Governor of the state, uncertainty exist as to who in the Department of Revenue will be accountable to local taxing authorities for the performance of such critical local tax administration,

NOW THEREFORE, be it resolved that the Claiborne Parish Police Jury as a local taxing authority and /or governing body, that each member of the legislative delegation for the Parish of Claiborne is urged to vigorously oppose any and all proposed legislation that transfers the administration and collection of local sales and use taxes to the Louisiana Department of Revenue; and

BE IT FURTHER RESOLVED that a copy of this resolution be sent forthwith to said legislators so that they will be made aware of our position on this matter,

President Scott Davidson reminded all Jurors of the mandatory (1) hour of Sexual Harassment Training required by December 31, 2019 for all Parish employees. Dept. Heads and Jurors are required to have (2) hours of training.

President Scott Davidson reminded all Jurors that Bosch & Statham began the field work for the Parish's annual audit on Monday, April 8, 2019.

President Scott Davidson read aloud a notice that effective July 1, 2019, the employer contribution of the DARS retirement will increase from 1.25% to 4.00% for the period July 1, 2019 to June 30, 2020.

Upon motion by James Laird, duly seconded by Keven Gray, the Jury unanimously approved the driveway repair requests under the Parish's Hardship Policy for the following: Jo Ann Kennedy of 128 Country Loop, Mary Kennedy of 134 Country Loop, Georgia Kennedy of 164 Country Loop, and Mary Stanley of 130 Country Loop – all are in Claiborne Parish, but, have Bernice addresses. Road Superintendent Tommy Durrett stated that all paperwork has been verified and they qualify for this hardship.

Upon motion by Kevin Gray, duly seconded by AD Williams, the Jury unanimously approved the Parish's 3-year Transportation Plan as required per the Parish Transportation Act.

Upon motion by Kevin Gray, duly seconded by Mark Furlow, the Jury unanimously approved the setting of the date for the public hearing for the abandonment and removal of the entirety of Shaw Spur Rd. (Parish Road #92) from the Parish Road System – Wednesday, May 8, 2019 at 9:00 am in the Jury Conference Room.

Upon motion by James Laird, duly seconded by AD Williams, the Jury unanimously approved the setting of the date for the public hearing for the abandonment and removal of the entirety of Greenwood Place Road (Parish Road #474) from the Parish Road System – Wednesday, May 8, 2019 at 9:00 am in the Jury Conference Room.

Upon much motion by Joe Merritt, duly seconded by Rev. Willie Young, the Jury tabled until May 8, 2019, the request from Mr. Jim Ross, Manager of Kinnebrew Land, LLC, in a letter received April 2, 2019, requesting that the Parish start the process for the abandonment and removal of a portion of Clear Lake Road (Parish Road #327) beginning at Hwy 79 and running approximately 1.3 miles. Rev. Willie Young and Joe Merritt were against closing that section of the road and Rev. Young stated that he felt the damage from the logging companies on the road should be repaired/paid for by the contractor who cut the timber. After much discussion, the motion was table until next month, so all jurors could examine the road and have a better understanding of the situation and request.

Upon motion by Gil Dowies, duly seconded by Mark Furlow, the Jury unanimously approved, upon recommendation from the Roads Committee, the 2019-2020 Employee renewal rates for the parish employees' health insurance as submitted by Blue Cross Blue Shield of Louisiana. (Renewal rates decreased by 1.67% over the current year rates)

Upon motion by Gil Dowies, duly seconded by Mark Furlow, the Jury unanimously approved, upon recommendation from the Roads Committee, that the Police Jury contract DINA Dental to provide elective dental insurance for the 2019-2020 year due to an average savings of approximately 10%. (Parish was previously with Starmount/Always Care).

Upon motion by Mark Furlow, duly seconded by Kevin Gray, the Jury unanimously approved, upon motion by the Roads Committee, to enter into an agreement with Mrs. Shelia Kirkpatrick to mow and upkeep the adjudicated property on Dawson St, Haynesville, LA.

At this time, Parish Coroner, Dr. Mark Haynes gave his monthly report: There were 10 deaths – (2) ER, (1) Autopsy, (2) On Scene, (5) w/o autopsy, and (3) CEC's.
