The Claiborne Parish Police Jury met in regular session in the Jury Chambers of the Claiborne Parish Police Jury Complex, located at 507 West Main Street in Homer, LA at 10:00 a.m. on the 5<sup>th</sup> of May 2021. A resolution approving the holding of an election in Claiborne Parish Wards 2 and 3 Recreation District of the Parish of Claiborne, State of Louisiana, on Saturday, October 9, 2021, to authorize the levy of a special tax therein.

WHEREAS, the Board of Commissioners of Claiborne Parish Wards 2 and 3 Recreation District of the Parish of Claiborne, State of Louisiana (the "Governing Authority"), acting as the governing authority of Claiborne Parish Wards 2 and 3 Recreation District of the Parish of Claiborne, State of Louisiana (the "District"), adopted a resolution on March 23, 2021, calling a special election in the District on Saturday, October 9, 2021, to authorize the levy of a special tax therein; and

WHEREAS, the governing authority of the District has requested that this Police Jury, acting as the governing authority of the Parish of Claiborne, State of Louisiana, give its consent and authority for the District to hold the aforesaid election, and in the event that the election carries to continue to levy and collect the special tax provided for therein; and

WHEREAS, as required by Article VI, Section 15 of the Constitution of the State of Louisiana of 1974, it is now the desire of this Police Jury to approve the holding of said election and in the event that the election carries, to continue to levy and collect the special tax provided for therein;

NOW, THEREFORE, BE IT RESOLVED by the Police Jury of the Parish of Claiborne, State of Louisiana, acting as the governing authority of said Parish, that:

SECTION 1. In compliance with the provisions of Article VI, Section 15 of the Constitution of the State of Louisiana of 1974, and in accordance with the request of the Board of Commissioners of Claiborne Parish Wards 2 and 3 Recreation District of the Parish of Claiborne, State of Louisiana, this Police Jury hereby approves the holding of an election in the District, on Saturday, October 9, 2021, at which election there will be submitted the following proposition, to-wit:

#### CLAIBORNE PARISH WARDS 2 AND 3 RECREATION DISTRICT (TAX CONTINUATION)

Shall Claiborne Parish Wards 2 and 3 Recreation District of the Parish of Claiborne, State of Louisiana (the "District"), continue to levy a special tax of five (5) mills on all the property subject to taxation in the District (an estimated \$213,800 reasonably expected at this time to be collected from the levy of the tax for an entire year), for a period of ten (10) years, beginning with the year 2021 and ending with the year 2030, for the purpose of maintaining and operating the

District's recreational facilities, for purchasing of necessary equipment and paying the cost of maintaining and supervising the recreational facilities?

SECTION 2. In the event the election carries, this Police Jury does hereby further consent to and authorize the District to continue to levy and collect the special tax provided for therein.

President Scott Davidson announced that Coroner Dr. Mark Haynes was unable to attend this morning's meeting due to the fact he was having a small medical procedure this morning and that he will give the May report at the June Police Jury meeting.
