### **MINUTES**

Of the Regular Meeting, of The Claiborne Parish Police Jury 10:00 a.m. June 5, 2019 Police Jury Chambers 507 West Main Street Homer, LA 71040

A Public Hearing was held at 9:00 am for the FY2020-FY2021 Louisiana Community Development Block Grant (LCDBG) Program, followed by a Road Committee Meeting at 9:15 am in the Conference Room.

The Claiborne Parish Police Jury met in regular session in the Jury Chambers of the Claiborne Parish Police Jury Complex, located at 507 West Main Street in Homer, LA at 10:00 a.m. on the 5<sup>th</sup> of June 2019. On being called to order by President, Scott Davidson, the following Jurors were present:

### SPECIAL RESOLUTION

A Special Resolution in Honor and Recognition of the Claiborne Academy Rebels Winning the MAIS Class A State Baseball Championship on Saturday, May 18, 2019.

WHEREAS, the Claiborne Parish Police Jury wishes to recognize the Claiborne Academy Rebels baseball team for winning the 2019 Class A State Championship against Tunica Academy by a score of 7-6 which clinched the championship series two games to one and capped a 28-2 championship season; and

WHEREAS, this was the Rebels FIRST State Baseball Championship Title in school history, and

WHEREAS, A. Y. Heard, a senior was named the series Most Valuable Player; and

WHEREAS, Claiborne Academy accomplished this feat by advancing through the MIAS playoffs by beating Wilkerson Academy of Woodville, MS by a count of two games to none in the second round and then defeating Tallulah Academy to claim the South State Championship by the count of two games to none; and

WHEREAS, the CA Baseball Team was led by a core of three senior All-State Players – A. Y. Heard, Wyatt Fain and Cameron Carraway to the school's first ever State Baseball Championship; and

WHEREAS, this achievement has brought great honor and recognition to Claiborne Academy, and to the citizens of Claiborne Parish; and

NOW, THEREFORE BE IT RESOLVED that the Claiborne Parish Police Jury does hereby officially recognize and congratulate the players of the Claiborne Academy Baseball Team, Head Coach Bill Moseley and his Coaching Staff – Rayne Lewis and Sam Bolen, the CA Administration and the CA School Faculty and Student Body.

At this time, Mr. Robert Mills, Candidate for Senate District #36 addressed the Jury and asked their vote during the 2019 Fall Election for District #36 Senate.

President Scott Davidson reminded all Jurors that they are required to complete one (1) hour of Ethics Training per year.

President Scott Davidson reminded all Jurors of the mandatory one (1) hour of Sexual Harassment Training required by December 31, 2019 for all Parish employees. Dept. Heads and Jurors are required to have two (2) hours of training.

President Scott Davidson read aloud a notice, received May 15, 2019 of a correction from May 5, 2019, effective July 1, 2019, the employer contribution of the Registrars of Voters Employees' Retirement System employer contribution rate will increase to 18.00% for the period July1, 2019 to June 30, 2020. (17.00% currently)

President Scott Davidson read aloud the notice that the Guardian Journal will be the Official Journal of the Claiborne Parish Police Jury beginning July 1, 2019. The period will be July 1, 2019 until June 30, 2020 as per the rotation schedule adopted by the Claiborne Parish Police Jury on June 4, 2014.

President Scott Davidson reminded Jurors of the employee health insurance meeting on June 12, 2019 at noon at the Claiborne Parish Library. (All full-time Police Jury employees must attend)

President Scott Davidson read aloud the following required notice concerning the renewal of the Watershed's Sales Tax: - Notice is hereby given that at its meeting to be held on Wednesday, July 10, 2019, at 10:00 a.m. in the Jury Chambers of the Claiborne Parish Police Jury Complex, located at 507 West Main Street, Homer, Louisiana, the Police Jury plans to consider adopting a resolution ordering and calling an election to be held in Claiborne Parish to authorize the renewal for the continuation of the Police Jury's 1/8% sales and use tax for the support of the Claiborne Parish Watershed District and placing the proposition on the November 16, 2019 ballot. The current 1/8 of a cent sales and use tax expires on December 31, 2020.

President Scott Davidson read aloud the notice per a letter received May 24, 2019, that the Police Jury has been awarded \$16,200 in FY 2018-2019 CWEF funds for the Summerfield Water System for repairs at the central pump station and for the installation of a main water control meter.

Upon motion by Kevin Gray, duly seconded by AD Williams, the Jury unanimously approved the letter of resignation for Justice of the Peace Ronnie McKenzie, dated May 7, 2019, effective June 1, 2019. Per Secretary State's Office, an election for the vacated seat will be held on October 12, 2019.

Upon motion by Paul Cook, duly seconded by AD Williams, the Jury unanimously approved Resolution 2019 – 013 – A Resolution Authorizing the President and Secretary-Treasurer to Sign Documents on Behalf of the Claiborne Parish Police Jury Concerning Transmittal of the 2018 Audited Financial Statements and the 2018 AUP's.

Upon motion by Gil Dowies, duly seconded by Kevin Gray, the Jury unanimously voted to allow CMMC Board to submit a name to the Police Jury, as requested by the Northwest LA Human Services District

Board, to replace Mrs. Jamie Crumpler who resigned due to her inability to finish term due to schedule conflicts. (the Police Jury will fill the seat on 7/10/2019)

At this time, Parish Coroner, Dr. Mark Haynes gave his monthly report: There were 6 deaths – (6) ER, (1) Autopsy, (3) On Scene, (2) ER Deaths, (3) w/o autopsy, and (4) CEC's.

Mark Furlow presented the Road Committee report -

Upon motion by Mark Furlow, duly seconded by Kevin Gray, the Jury unanimously approved the inoffice hire of Travis Kimp for Truck Driver at \$13.75 per hour beginning 6/8/2019.

Upon motion by Mark Furlow, duly seconded by Gil Dowies, the Jury unanimously approved to enter into a Brownsfield Grant (total grant amount \$60,000) with LADEQ for the proposed new branch of the library in Haynesville. The Police Jury can exit out of this grant with no financial responsibility if the site is deemed unacceptable for construction of the new branch.

Upon motion by Mark Furlow, duly seconded by Kevin Gray, the Jury unanimously approved moving the LAMP Fund in the amount of \$5,616.22 and a CD in the amount of \$10,439.41 to the Sales Tax Fund.

As requested by District #10 Juror Rev. Willie Young, Sr., Mrs. Tina Haynes gave a brief update on the state of affairs at Claiborne Memorial Medical Center and its search for a new CFO and the CMMC Board's time-line for naming a permanent CEO.
