#### **MINUTES**

Of the Regular Meeting, of The Claiborne Parish Police Jury 10:00 a.m. July 10, 2019 Police Jury Chambers 507 West Main Street Homer, LA 71040

The Claiborne Parish Police Jury met in regular session in the Jury Chambers of the Claiborne Parish Police Jury Complex, located at 507 West Main Street in Homer, LA at 10:00 a.m. on the 10<sup>th</sup> of July. On being called to order by President, Scott Davidson, the following Jurors were present:

Mark Furlow, Kevin Gray, A.D. Williams, Paul Cook, Tommy Sanders, Gil Dowies, and Rev. Willie Young, Sr.

District 1 Juror James Laird and District 7 Juror Joseph Merritt were absent.

There were 16 others in attendance which included, Secretary-Treasurer Dwayne R. Woodard, Parish Road Superintendent Tommy Durrett, Sheriff Ken Bailey, Claiborne Parish Coroner Dr. Mark Haynes, OEP Director Dennis Butcher, OOCS Director Tim Cain, Sam Dowies of the Claiborne Parish Watershed District, CMMC Interim CEO Tina Haynes, Angie Costaleis of CMMC, John Monzingo of the Claiborne Parish 4-H, Michael Allen – Candidate for Claiborne Parish Sheriff, Jerry Whitton of Homer, Mr. and Mrs. Wade Bishop - Candidate for Senate District #33, Murphy Chestnut of Senator John Kennedy's Office, and Mark Crenshaw of Homer.

The meeting was opened with a word of Prayer led Rev. Willie Young, followed by the Pledge of Allegiance led by Paul Cook.

Upon motion by Mark Furlow, duly seconded by A.D. Williams, the Jury unanimously voted to adopt the Regular Agenda as presented.

Upon motion by Kevin Gray, duly seconded by Tommy Sanders, the Jury unanimously approved the consent agenda as follows:

At this time, President Scott Davidson allowed Mr. Wade Bishop, candidate for Senate District #33 seat, to address the Jury and public about his campaign and his platform for the Senate District #33 seat.

President Scott Davidson requested to handle the amendments to the agenda at this time.

President Scott Davidson read aloud a notice - the PERS employer rate for Plan A will increase to 12.25% (currently 11.50%), effective January 1, 2020. The employee rate will remain at 9.00%.

Upon motion by Paul Cook, duly seconded by Gil Dowies, the Jury unanimously approved, upon request by Road Superintendent, Tommy Durrett, the following merit raises - they will be effective for the pay period beginning July 11, 2019:

President Scott Davidson read aloud the following notice – The Claiborne Parish Police Jury will adopt the 2019 ad valorem tax millages for all funds on Wednesday, September 11, 2019, at 10:00 am at the Claiborne Parish Police Jury Administrative Building in the Jury Chambers, located at 507 West Main St, Homer, LA 71040.

President Scott Davidson read aloud the following notice – The Claiborne Parish Police Jury will sit as a Board of Review for the 2019 tax roll for a 15-day period beginning September 8, 2019 and ending September 22, 2019. The hearing date for the Board of Review will be on Wednesday, September 11, 2019 at 10:00 am in the Jury Chambers of the CPPJ Administration Building located at 507 West Main St, Homer, LA 71040.

Upon motion by Gil Dowies, duly seconded by Mark Furlow, the Jury unanimously approved the request from the SOS Office, received on June 21, 2019, to purchase three (3) computers and monitors for the ROV Office to machines that will be Windows 10 compatible – estimated cost of \$2,500.

Upon motion by Paul Cook, duly seconded by Kevin Gray, the Jury unanimously approved the acceptance of the Annual Precinct Survey, dated July 3, 2019, as required by LA R.S.18:532B concerning precincts that have less than 300 registered voters. (no changes from 2018 survey)

Upon motion by Gil Dowies, duly seconded by Tommy Sanders, the Jury unanimously approved Resolution 2019–014 – A Resolution Ordering and Calling A Special Election to be Held in the Parish of Claiborne, State of Louisiana, to Authorize the Levy of a Sales and Use Tax therein; Making Application to the State Bond Commission in Connection Therewith; and providing for Other Matters in Connection Therewith (renewal of the 1/8<sup>th</sup> cent sales tax for the CPWSD).

The following resolution was offered by Gil Dowies and seconded by Tommy Sanders:

## RESOLUTION

A resolution ordering and calling a special election to be held in the Parish of Claiborne, State of Louisiana, to authorize the levy of a sales and use tax therein; making application to the State Bond Commission in connection therewith; and providing for other matters in connection therewith.

BE IT RESOLVED by the Police Jury of the Parish of Claiborne, State of Louisiana (the "Governing Authority"), acting as the governing authority of the Parish of Claiborne, State of Louisiana (the "Parish"), that:

SECTION 1. <u>Election Call</u>. Subject to the approval of the State Bond Commission, and under the authority conferred by the Constitution of the State of Louisiana of 1974, the

applicable provisions of the Louisiana Election Code, and other constitutional and statutory authority, a special election is hereby called and ordered to be held in the Parish on **SATURDAY, NOVEMBER 16, 2019**, between the hours of seven o'clock (7:00) a.m. and eight o'clock (8:00) p.m., in accordance with the provisions of La. R.S. 18:541, and at the said election there shall be submitted to all registered voters qualified and entitled to vote at the said election under the Constitution and laws of this State and the Constitution of the United States, the following proposition, to-wit:

# PROPOSITION (SALES & USE TAX RENEWAL)

Shall the Parish of Claiborne, State of Louisiana (the "Parish"), under the provisions of law, be authorized to levy and collect a tax of one-eighth of one percent (1/8%) (the "Tax") (an estimated \$156,000 reasonably expected to be collected annually from levy of the Tax) upon the sale at retail, the use, the lease or rental, the consumption, and the storage for use or consumption, of tangible personal property and on sales of services in the Parish for a period of seven (7) years, commencing January 1, 2021, with the avails or proceeds of the Tax (after paying reasonable and necessary costs of collecting and administering the Tax), to be dedicated to the conservation and development of natural resources for agricultural, commercial, residential or other purposes, including surface and ground water, promoting safety on lakes and waterways, both within and without the Parish, and including equipment and improvements necessary for the above purposes, to be administered by the Claiborne Parish Watershed District pursuant to an intergovernmental agreement with the Parish?

SECTION 2. <u>Publication of Notice of Election</u>. A Notice of Special Election shall be published in the *Guardian Journal*, a newspaper of general circulation within the Parish, published in Homer, Louisiana, and being the official journal of the Parish, once a week for four consecutive weeks, with the first publication to be made not less than forty-five (45) days nor more than ninety (90) days prior to the date of the election, which Notice shall be substantially in the form attached hereto as "Exhibit A" and incorporated herein by reference the same as if it were set forth herein in full.

Notwithstanding the foregoing, prior to the publication of the Notice of Election, the President is authorized and directed to make any amendments to the foregoing proposition that may be required to comply with any state or federal regulatory agencies.

SECTION 3. <u>Canvass</u>. This Governing Authority shall meet at its regular meeting place, the Jury Chambers of the Police Jury Complex, 507 West Main Street, Homer, Louisiana, on **WEDNESDAY**, **DECEMBER 4, 2019**, at **TEN O'CLOCK (10:00) A.M.**, and shall then and there in open and public session proceed to examine and canvass the returns and declare the result of the said special election.

SECTION 4. <u>Polling Places</u>. The polling places for the precincts in the Parish are hereby designated as the polling places at which to hold the said election, and the Commissioners-in-Charge and Commissioners, respectively, will be the same persons as those designated in accordance with law.

SECTION 5. <u>Election Commissioners</u>; <u>Voting Machines</u>. The officers designated to serve as Commissioners-in-Charge and Commissioners pursuant to Section 4 hereof, or such substitutes therefor as may be selected and designated in accordance with La. R.S. 18:1287, shall hold the said special election as herein provided, and shall make due returns of said election for the meeting of the Governing Authority to be held on Wednesday, December 4, 2019, as provided in Section 3 hereof. All registered voters in the Parish will be entitled to vote at the special election, and voting machines shall be used.

SECTION 6. <u>Authorization of Officers</u>. The Secretary-Treasurer of the Governing Authority is hereby empowered, authorized and directed to arrange for and to furnish to said election officers in ample time for the holding of said election, the necessary equipment, forms and other paraphernalia essential to the proper holding of said election and the President and/or

Secretary-Treasurer of the Governing Authority are further authorized, empowered and directed to take any and all further action required by State and/or Federal law to arrange for the election.

SECTION 7. <u>Furnishing Election Call to Election Officials</u>. Certified copies of this resolution shall be forwarded to the Secretary of State, the Clerk of Court and *Ex-Officio* Parish Custodian of Voting Machines of Claiborne Parish and the Registrar of Voters of Claiborne Parish, as notification of the special election, in order that each may prepare for said election and perform their respective functions as required by law.

SECTION 8. <u>Application to State Bond Commission</u>. Application is made to the State Bond Commission for consent and authority to hold the special election as herein provided, and in the event said election carries for further consent and authority to continue to levy and collect the sales and use tax provided for therein. A certified copy of this resolution shall be forwarded to the State Bond Commission on behalf of this Governing Authority, together with a letter requesting the prompt consideration and approval of this application.

# PROPOSITION (SALES & USE TAX RENEWAL)

The said special election will be held in accordance with the applicable provisions of Chapter 5, Chapter 6-A and Chapter 6-B of Title 18 of the Louisiana Revised Statutes of 1950, as amended, and other constitutional and statutory authority, and the officers appointed to hold the said election, as provided in this Notice of Special Election, or such substitutes therefor as may be selected and designated in accordance with La. R.S. 18:1287, will make due returns thereof to said Governing Authority, and NOTICE IS HEREBY FURTHER GIVEN that the Governing Authority will meet at its regular meeting place, the Jury Chambers of the Police Jury Complex, 507 West Main Street, Homer, Louisiana, on WEDNESDAY, DECEMBER 4, 2019, at TEN O'CLOCK (10:00) A.M., and shall then and there in open and public session proceed to examine and canvass the returns and declare the result of the said special election. ## **RESOLUTION 2019-015**

A resolution approving the issuance, sale and delivery of Two Hundred Fifty Thousand Dollars (\$250,000) of Limited Tax Certificates of Indebtedness, Series 2019, of Claiborne Parish Fire Protection District No. 5, Louisiana.

WHEREAS, the Board of Commissioners of Claiborne Parish Fire Protection District No. 5, Louisiana (the "District"), proposes to authorize the issuance, sale and delivery of \$250,000 of its Limited Tax Certificates of Indebtedness, Series 2019 (the "Certificates"), to pay costs of acquiring, constructing and improving fire protection facilities and equipment in and for the Issuer and costs of issuance of the Certificates, pursuant to a resolution adopted by said Board of Commissioners on June 6, 2019 (the "Resolution"); and

WHEREAS, it is now the desire of this Police Jury of the Parish of Claiborne, State of Louisiana, to approve the issuance, sale and delivery of the Certificates as required by Article IV, Section 15 of the Constitution of the State of Louisiana of 1974 and the authority supplemental thereto;

NOW, THEREFORE, BE IT RESOLVED by the Police Jury of the Parish of Claiborne, State of Louisiana, acting as the governing authority of said Parish, that:

SECTION 1. In compliance with the provisions of Article VI, Section 15 of the Constitution of the State of Louisiana of 1974 and other authority supplemental thereto, and in accordance with the request of the Board of Commissioners of Claiborne Parish Fire Protection District No. 5, Louisiana, this Police Jury hereby approves the issuance, sale and delivery of \$250,000 of Limited Tax Certificates of Indebtedness, Series 2019, of the District, maturing not later than March 1, 2029, and bearing interest at a rate or rates not exceeding 4.00% per annum, all in accordance with the parameters and provisions of the Resolution. The Bonds shall be secured by and payable solely from an irrevocable pledge and dedication of the avails and proceeds of the District's ten and thirty-seven hundredths (10.37) mills tax authorized to be levied and collected in the years 2020 through 2030, pursuant to elections held in the District on May 2, 2009 and April 28, 2018, and neither the Parish of Claiborne nor this Police Jury shall in any way be liable for the payment of the principal of and/or interest on the Certificates.
