The Claiborne Parish Police Jury met in regular session in the Jury Chambers of the Claiborne Parish Police Jury Complex, located at 507 West Main Street in Homer, LA at 10:00 a.m. on the 11th of September 2024, on being called to order by Vice-President Mark Furlow, the following jurors were present:

Larry Ford, Mark Furlow, Kevin Gray, Paul Cook, Joseph Merritt, Jr., Malcolm Cooper, Gil Dowies, and Willie Young.

District Four Juror Mary McDaniel and District Five Juror President Scott Davidson were absent.

There were 21 others in attendance which included Secretary-Treasurer Dwayne R. There was a Road Committee Meeting held at 9:00 a.m. in the Conference Room.

Vice-President Mark Furlow called the meeting to order.

The meeting was opened with a word of Prayer was led by Rev. Willie Young, followed by the Pledge of Allegiance led by Paul Cook.

Upon motion by Kevin Gray, duly seconded by Paul Cook, the Jury unanimously voted to adopt the Regular Agenda as presented.

Upon motion by Gil Dowies, duly seconded by Joseph Merritt, the Jury unanimously approved the following consent agenda:

- 1. Approval of the August 7, 2024, regular meeting minutes as published in the Official Journal.
- 2. Payment of the August 2024 bills as approved by the Claims Committee.
- 3. Request from the Town of Haynesville, in a letter received on August 13, 2024, requesting the Hwy Dept for deliver one (1) load of cold mix to the City Shop located on Spring Street and assistance from the CPPJ Hwy Dept with the mowing of certain rights-of-way and ditches within the Twon of Haynesville. This work will be performed under the Town's ad valorem tax credit.
- 4. Request from the Claiborne Parish Fair Board, in a letter received on August 21, 2024, requesting their budgeted amount of \$4,000 and to be included in the Parish's 2025 budget for the same amount.

Regular Agenda

Vice-President Mark Furlow reminded everyone that all Parish Employees are required to complete one (1) hour of ethics training by December 31, 2024.

Vice-President Mark Furlow also reminded everyone that one (1) hour of Preventing Sexual Harassment training is required to be completed by December 31, 2024, by all parish employees – Department Heads and Jury Officers have a two (2) hour training requirement.

Secretary-Treasurer Dwayne R. Woodard announced that the training session for all Parish employees and District board members will be held on October 3rd at Claiborne Parish Library at 8:00 am. This is presented by our insurance group LRPIC at no cost to the Parish.

Vice-President Mark Furlow read aloud a NOTICE OF SPECIAL ELECTION – NOTICE IS HEREBY GIVEN that a special Election will be held within the Parish on SATURDAY, DECEMBER 7, 2024, to authorize to continue the levy and collect a sales and use tax of 0.5% for a period of 10 years. (Renewal of the ½ sales tax in support of CMMC)

Vice-President Mark Furlow read aloud a PUBLIC NOTICE – A Public sale of property will begin at 3:00 pm on Monday September 16, 2024, in the Conference Room of the CPPJ located at 507 West Main Street, for Parcel #9730033400 or 268 Washington Street, Homer, LA 71040. Minimum bid has been set at \$5,974.20.

Vice-President Mark Furlow announced that the Region IVPJAL Meeting will be held on Wednesday, October 23, 2024, at 6:00 pm at the Natchitoches Events Center. Please see Leigh Ann to RSVP.

Vice-President Mark Furlow read aloud a notice that Senator Bill Cassidy, MD is hosting a Rural Community Funding Summit, along with the LMA, PJAL, & LITA Corp at the Minden Rec Complex on October 8, 2024.

Vice-President Mark Furlow read aloud a notice from the LA State Office of Broadband Development Connectivity (ConnectLA) concerning GUMBO 2.0 or BEAD funds.

Upon motion by Kevin Gray, duly seconded by Paul Cook, the Jury unanimously tabled the request from Doug Efferson, Executive Director of the NWLHSD, in a letter dated June 3, 2024, reminding the Police Jury that they need to appoint a representative to replace Don Pledger on the Service District Board.

Upon motion by Rev. Willie Young, duly seconded by Kevin Gray, the Jury unanimously approved the Special Events Permit Application from the Morris Shelton Trail Ride being held on September 20 & 21, 2024 at 1025 White Oak Rd, Homer, LA 71040.

Upon motion by Gil Dowies, duly seconded by Paul cook, the Jury unanimously voted to leave the regular meeting session and enter a Public Hearing for the 2024 Board of Review.

At this time, the presentation of the assessment of property values for the 2024 property tax rolls was given. The total Assessed Value of property in Claiborne Parish for the tax year 2024 is \$149,532,191 of which \$20,381,153 is Homestead Exempted property.

Tax Assessor Bob Robinson stated there have been no formal objections to the assessments other than one communications tower company which has been resolved. He has received no formal appeals by phone, email, or in person reported to his office.

Secretary-Treasurer Dwayne R. Woodard stated there have been no objections reported to his office via email, telephone, mail, or in-person regarding the 2024 Tax Assessment figures.

Upon motion by Paul Cook, duly seconded by Joseph Merritt, the Jury voted to leave the Public Hearing for the 2024 Board of Review and return to the regular meeting of the Claiborne Parish Police Jury.

Upon motion by Gil Dowies, duly seconded by Kevin Gray, the Jury unanimously accepted the assessment of property values for the 2024 property tax rolls.

Upon motion by Paul Cook, duly seconded by Keivn Gray, the Jury unanimously adopted Resolution 2024-019 – A Resolution Levying Millage for the 2024 Tax Roll for the Claiborne Parish Police Jury.



Parish Coroner Dr. Mark Haynes gave his monthly report. The Coroner's Office had a total of 12 deaths: (8) ER/Hospice, (1) Autopsy, (0) other, (3) On Scene no autopsy, and (10) CECs.

CMMC CEO Tina Haynes gave her update on the hospital and clinics. They are seeing moderate cases of COVID and the hospital has been very busy. Flu Vaccines are currently available. The CMMC clinics are seeing a record numbers of patients. The old Haynesville Hospital abetment is being done and making sure all asbestos is removed from the building.
