MINUTES Of the Regular Meeting, of The Claiborne Parish Police Jury 10:00 a.m. December 4, 2024 Police Jury Chambers 507 West Main Street Homer, LA 71040

The Claiborne Parish Police Jury met in regular session in the Jury Chambers of the Claiborne Parish Police Jury Complex, located at 507 West Main Street in Homer, LA at 10:00 a.m. on the 4th of December 2024. On being called to order by President Scott Davidson, the following Jurors were present:

Larry Ford, Mark Furlow, Kevin Gray, Mary McDaniel, Paul Cook, Joe Merritt, Malcolm Cooper, Gil Dowies, and Rev. Willie Young.

There were eighteen (18) others in attendance which included Secretary-Treasurer Dwayne R. Woodard, Road Superintendents Chad Verdin and Brant Cupp, Parish Coroner Dr. Mark Haynes, District 11 Representative Rashid "Mon" Young, Claiborne Parish Director of Libraries Mrs. Pam Suggs, Library Historian Mr. Wesley Harris, Claiborne Parish Registrar Tracy Lowrey, Tax Assessor Elect Mrs. Katie Coburn, Kathy Babers Community Liaison for Speaker of the House Mike Johnson's Office, Parish Digital Liaison Jerry Hillege, Claiborne Parish Fire District 4 Board member Ronald Day, LSU AgCenter Regional Coordinator Lee Faulk, Town of Haynesville Mayor Roderick Hampton, Town of Homer Mayor Xanthe Seals, Rev. Steve Fowler of the Corner Stone Church of Homer, and Mr. Jerry Whitton of Homer.

The meeting was opened with a word of Prayer led by Rev. Willie Young, followed by the Pledge of Allegiance led by Paul Cook.

At this time President Scott Davidson welcomed Mrs. Kathy Babers of the Speaker of the House Mike Johnson's office. Mrs. Babers presented Dr. William Mark Haynes with the certificate of Congressional Recognition for earning the 2024 Customer Focus Physician Summit Award. Dr. Mark Haynes thanked everyone who held a part of his earning this prestigious honor. He told the Jury that many patients and previous physicians, including his dad, had a part in molding him into the physician that he is today. Dr. Mark expressed his gratitude to the doctors, hospital and people of Claiborne Parish.

Upon motion by Kevin Gray, duly seconded by Paul Cook, the Jury unanimously voted to adopt the Regular Agenda as presented.

Upon motion by Kevin Gray, duly seconded by Mark Furlow, the Jury unanimously voted to amend the agenda and add the following item:

1. Request from Town of Haynesville for help cutting trees on the Golf Course and (1) load of SB2 and Asphalt to be delivered to the city shop. (This will be under the ad valorem tax credit for the Town of Haynesville)

At this time President Scott Davidson handled the amended item on the agenda.

Upon motion by Mark Furlow, duly seconded by Mary McDaniel, the Jury unanimously approved the request from the Town of Haynesville for help cutting trees on the Golf Course and to have a load each of SB2 and Asphalt delivered to the city shop.

Upon motion by Gil Dowies, duly seconded by Mary McDaniel, the Jury unanimously approved the consent agenda.

- 1. Approval of the November 4, 2024, regular meeting minutes as published in the Official Journal.
- 2. Payment of the November 2024 bills as approved by the Claims Committee.

Regular Agenda:

President Scott Davidson read aloud a notice that all Parish Employees are required to complete one (1) hour of ethics training by December 31, 2024.

President Scott Davidson reminded everyone that one (1) hour of Preventing Sexual Harassment Training is required to be completed by December 31, 2024, by all Parish Employees – Department Heads and Jury Officers have a two (2) hour training requirement.

President Scott Davidson read aloud a NOTICE OF SPECIAL ELECTION – NOTICE IS HEREBY GIVEN that a Special Election will be held within the Parish on SATURDAY, DECEMBER 7, 2024, to authorize to continue the levy and collect a sales use tax of 0.5% for a period of 10 years. (renewal of the ½ sales tax in support of CMMC)

Reminder- 2024 Christmas Holiday – lunch Monday, December 23rd at the Road Barn on Hwy 2, off Tuesday the 24th through Wednesday, January 1st, return to work on Thursday, January 2nd, 2025.

President Scott Davidson read aloud a notice – the 2025 LGAP and SWEF Application Portal will open on November 1, 2024, and close on February 28, 2025, at 4:00 pm per letter from the State Office of Community Development received on October 33, 2024. The maximum per Parish is now \$300,000 for LGAP and \$350,000 for CWEF.

At this time, Parish Coroner Dr. Mark Haynes gave his update for the Coroner's Office for the month of November. 20 total deaths: (6) Hospice/ER, (7) on scene with no autopsy, (5) requiring autopsies, (2) at CMMC, and (4) CEC's.

Dr. Mark Haynes stated that it's flu season, the flu shots are out, and he recommends that everyone should get a flu shot. Covid is sporadic, and rather mild.

Upon motion by Mary McDaniel, duly seconded by Gil Dowies, the Jury unanimously approved the request from the Claiborne Parish Library Board of Control, in a letter dated November 11, 2024, requesting the re-appointment of the following Board Members to another five-year term – Mrs. Dianne Spigner of Athens, Mrs. Trudy Walker Clark of Homer, and Mrs. Patricia Eddens Davis of Bernice. Their terms currently expired on December 31, 2024.

Upon motion by Kevin Gray, duly seconded by Paul Cook, the Jury unanimously approved the lowest qualified bid for the purchase of CRS-2, CRS-P2, and CSS-1H asphalt cement necessary for the maintenance of the Claiborne Parish Roads for the 2025 year.

ORDINANCE NO. 806

AN ORDINANCE ADOPTING AN OPERATING BUDGET OF REVENUE AND EXPENDITURES FOR THE FISCAL YEAR BEGINNING JANUARY 1, 2025, AND ENDING ON DECEMBER 31, 2025

BE IT ORDAINED by the Police Jury of Claiborne Parish, Louisiana, in a regularly called session, the Ordinance adopting an Operating Budget for Revenues and Expenditures for the fiscal year beginning January 1, 2025, and ending December 31, 2025.
